

#### **Choosing Limits** for your Lawyers' **Liability Insurance**

Firstly, you must determine the appropriate limits of coverage. Your insurance policy will specify a per claim limit of liability and an aggregate limit of liability. The per claim limit pertains to the amount available to cover damages and defense costs stemming from a single incident or event leading to a claim. When selecting a per claim limit we recommend reviewing your office's files - both open and recently closed - to estimate the value for each file. Then make sure you select a claim limit amount that will adequately cover your most substantial typical case. This exercise should provide a solid basis for choosing an appropriate per claim limit that safeguards you from personal exposure in the event of a malpractice claim.

Next, assess the aggregate limit of coverage required. The aggregate limit represents the maximum amount available to settle all claims within a policy year. If your aggregate limit matches the per claim limit, a single claim could deplete both limits within the same policy year. Be prepared for worst-case scenarios.

Finally, the deductible is what you would have to pay for a settlement or (dread the thought)

loss. Some attorneys opt for high deductibles to save money on their premium. Typically, the premium difference for a lower deductible is minimal, making it worthwhile to consider whether paying an extra amount in premium now, will save you more money down the road if you have a claim.. MLM's professional liability policy features a loss-only deductible, triggered only when MLM makes an indemnity payment on your behalf. Taking the time to thoroughly evaluate your practice and your capacity to cover a specific

deductible is a prudent and essential exercise. More attorneys are experiencing malpractice lawsuits, with some experts estimating that new attorneys may encounter three to four claims in their careers. Ensuring you have the right coverage will provide peace of mind when dealing with a malpractice claim. When renewing your policy, ensure that your initial analysis still aligns with your practice, and make necessary adjustments if needed.



# **Mental Health First Aid!**





On August 12th, the Crime Victim's Center of Chester County witnessed an outpouring


